According to Article 1, paragraph 1 of the Statute of the International Law Commission, one of the objects of the ILC is the promotion of the progressive development of International Law and its codification.

The Commission's work on a topic usually involves some aspects of the progressive development and the codification of International law, with the balance between the two varying depending on the particular topic
